sum of TEN THOUSAND FIVE HUNDRED and no/100--- (\$10,500.00) Dollars,

with interest at the rate of six (6 %) per centum per annum, to be repaid in installments of

One Hundred Five and no/100--- (\$105.00) Dollars upon the first

day of each and every calendar month hereafter until the full principal sum, with interest, has been paid.
