(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thousand Three Hundred and No/100----- DOLLARS (\$10,300.00), with interest thereon from date at the rate of Five & One-Half per centum per annum, said principal and interest to be repaid in monthly instalments of Eighty-Two & No/100 Dollars (\$ 82.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville"

on the western side of Conestee Avenue, in the City of Greenville, being the southern 40 feet of lot 39 and the northern 30 feet of lot 40, and shown on plat of South Cherokee Park, recorded in Plat Book A at Page 130, and described as follows:

BEGINNING at a stake on the western side of Conestee Avenue, 300 feet south from Elsie Avenue (formerly Saluda Street) at corner of property now of formerly owned by L. L. Clapp, and running thence with the line of said lot, N. 73 W. 173 feet to a stake on an alley; thence with the eastern side of said alley, S. 27 W. 70 feet to a stake; thence S. 63 E. 173 3/8 feet to a stake on Conestee Avenue; thence with the western side of said Avenue, N. 27 E. 70 feet to the beginning corner.
