TO ALL WHOM THESE PRESENTS MAY CONCERN.

Arthur B. Collier (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Eight Thousand Four Hundred and no/100-----  
DOLLARS (\$ 8,400.00-----), with interest thereon from date at the rate of Six (6%) ---  
per centum per annum, said principal and interest to be repaid in monthly instalments of

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW-ALIB MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the Southern side of Central Court, being known and designated as Lot 53 on North Sunset Hills, recorded in Plat Book L at page 92, and according to said plat having the following metes and bounds:

BEGINNING at an iron pin on the south side of Central Court, corner of Lots 52 and 53, and running thence S. 46-38 E. 185.4 feet to an iron pin on a 5 foot strip reserved for utilities; thence N. 56-45 E. 96 feet to an iron pin to Hudson line; thence with Hudson line, N. 55-40 W. 210 feet to an iron pin on South side of said court; thence S. 43-22 W. 60 feet to the beginning.
