NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances, made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements, thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwest corner of Stone Avenue and an unnamed (Mitchell St.) street, known as Lot No. 50 of Section H on plat of Stone Land Company recorded in the R.M.C. Office for Greenville County in Plat Book A, page 337, having the following boundaries:

BEGINNING at an iron pin at said corner and running thence with the unnamed (Mitchell St.) street S. 20.19 W. 175 feet to an iron pin; thence N. 71.50 W. 60 feet to Thomas Parks' line; thence with Parks' line, N. 20.19 E. 175 feet to an iron pin on Stone Avenue; thence with Stone Avenue, S. 71.50 E. 60 feet to the beginning corner.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagor forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
