"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oncal Township, lying on the southwest side of State Highway No. 415 and about five miles northwest of the City of Green, and being all of Lot No. 18, Section 1, as shown on a plat of subdivision known as EARIS VIEW, made by J.D. Calmes, April, 1961, recorded in the R.M.C. Orfice for Greenville County in Plat Book VV, page 101, and having the following courses and distances, to-wit:

BEGINNING on an iron pin on the margin of State Highway No. 415, joint corner of Lots Nos. 17 and 18, and runs thence S. 38-23 W. 200 feet to an iron pin; thence S. 51-37 E. 100 feet to an iron pin; thence N. 38-25 E. 200 feet to an iron pin on said highway; thence therewith, N. 51-37 W. 100 feet to the beginning, and being all of that property conveyed to the mortgagor by J.
