SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Thirteen Thousand, Five Hundred and No/100 (\$ 13,500,00) Dollars (or for luture advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Eighty-Six and 99/100 -----(s. 86.99) Dollars upon the first day of each and every calendar month hereafter in advance; until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a perfod of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

Forrester; thence N. 11-15 E. 653.2 feet to an iron pin which is 277.4 feet from an old iron pin on an extension of this line; thence along the line of other property belonging to Sue S. Forrester, S.78-38 W.347 feat to the beginning corner, which is witnessed by an iron pin 20.1 feet back on line, being the same conveyed to us by Sue S. Forrester by deed of even date, to be recorded herewith."
