All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina County of Greenville, in the City of Greenville, known as lot 5, Block E on plat of Carolina Court, recorded in plat book F at page 96, and having, according to a more recent survey of same by R. E. Dalton in February, 1944, the following meter and bounds, to-wit:

Beginning at an iron pin on the northeastern side of Fastlan Drive (formerly Wickliffe Street) which iron pin is situate 311.3 feet southeast from the intersection of Eastlan Drive (formerly Buena Vista Ave.), which iron pin is situate at the corner of lot 4, and running thence N 35-05 E, 176.2 feet to an iron pin on the right of way of the C. & W.
