MORTGAGE OF REAL ESTATE

To All Whom These Presents: May Concern:

Jack E. Shaw Builders, Inc., a South Carolina corporation with its principal place of

business in Greenville, S. C.

WHEREAS, I'we the aforesaid mortgagor (s) in and by my/our certain promissory note, in writing of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Fourteen Thousand, Five Hundred and No./100\$ 14, 500, 00) Dollars (or for luture advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Ninety-Three and 44/100 - - - - (\$ 93.44) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently Ninety-Three and 44/100 -

extended, will be due and payable 25... years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per ceptum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be, collectible as a part thereof, if the same be placed in the hands of any attorney for collection, or if said debt, do any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor is in consideration of the said debt and sum of money aforesaid, and for the better securing the payment theigeof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor (s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, and known and designated as Lot No. 11 of a subdivision known as Pinehurst, Section 2, property of W. J. Burty, plat of which was prepared by J. Mac Richardson, March 1960, and recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 153, and according to said plat having the following metes and, bounds, to-wit:

"BEGINNING at an iron pin on the western side of Linden Drive, the joint front corner of Lots Nos. 11 and 10, and running thence along the line of Lot No. 10, S. 80-51 W. 162.5 feet to an iron pin in the property line; thence N. 9-07 W. 66.1 feet to an iron pin; thence N. 20-25 W. 24 feet to an iron pin at the joint rear corner of Lots Nos. 11 and 12; thence N. 80-44 E. 167. I feet to an trop pin on the western side of Linden Drive; thence along the western side of Linden Drive, S. 9-09 E. 90 feet to an iron pin, point of beginning; being the same conveyed to the moregagor corporation by W. E. Shaw, as Trustee for W. E. Shaw and W. N., Leslie by deed dated August 15, 1961, to be recorded herewith."
