"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, so located near the North Greenville Junior College, being bounded by property of said College on the north, east and west, and on the east and south by Pearl M. Holcombe and D.E. Heath, being shown on a plat of property made for Dewey L. Calvert by Terry T. Dill, Surveyor, and having the following courses and distances, to-wit:

BEGINNING on an iron pin on the margin of Chinquapin Road, a road leading from Tigerville to Cross Plains Baptist Church, corner with D.E.
