Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal, that are next due on the note, on the first day of any month prior to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment; and "fivilede, further, that in the event the debt is paid in full prior to maturity and at that ting it is insured under the provisions of the National Hodsing Act, he will pay to the Mortgage an insurance premium charge of one per centum (1%) of the original principal amount thereof, except that in no event shall the adjusted premium exceed the aggregate amount of premium charges which would have been payable if the mortgage had continued to be insured until maturity; such payment to be applied by the fortgage upon its obligation to the Federal Housing Commissioner on account of mortgage insurance. tion to the Federal Housing Commissioner on account of mortgage insurance.

2. That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, he will pay to the Mortgages, on the first day of each month until the said note is fully paid, the following sums:

(a) If this mortgage and the note secured hereby are insured under the provisions of the National Housing Act and so long as they continue to be so insured, one-twelfth (%3) of the annual mortgage insurance premium for the purpose of putting the Mortgage in funds with which to discharge its obligation to the Federal Housing Commissioner for mortgage insurance premiums pursuant to the applicable provisions of the National Robusing Act; as amended, and regulations thereunder. The Mortgages shall, on the termination of its obligation to pay mortgage insurance premiums, credit to the account of the Mortgagor all payments made under the provisions of this subsection which the Mortgague has not become obligated to pay to the Federal Housing Commissioner.

A sum equal to the ground rents, if any, next due, plus the premiums that will next become due and nayable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes and assessments next due on the mortgaged property (all as estimated by the Mortgagee) less all sums already paid therefor divided by the number of months to elapse before one month prior to the date when such ground rents, premiums, taxes, and assessments will become delinquent, such sums to be held by Mortgagee in trust to pay said ground rents, premiums, taxes, and special assessments.
