TO ALL WHOM THESE PRESENTS MAY CONCERN:

**PLEASANT HOMES, INC.**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Eight Thousand Two Hundred and No/100ths**-----

**DOLLARS (\$ 8,200.00** ), with interest thereon from date at the rate of **six**-----  
per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being near the Town of Mauldin in Austin Township, Greenville County, State of South Carolina, being known and designated as Lot No. 11 as shown on a plat prepared by R.K. Campbell, R.L.S., dated March 29, 1960, entitled "Windsor Park", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book RR at page 25, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Swinton Drive at the joint front corner of Lots Nos. 10 and 11, and running thence with the line of Lot No. 10 S. 59-45 W. 180 feet to an iron pin in the subdivision property line; thence with the said subdivision property line S. 30-15 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 11 and 12; thence with the line of Lot No. 12 N. 59-45 E. 180 feet to an iron pin on the Western side of Swinton Drive; thence with the Western side of Swinton Drive N. 30-15 W. 100 feet to the point of beginning.

The subdivision, Windsor Park, in which the above described lot is located is the property conveyed to Pleasant Homes, Inc., James P. Moore and Otis P. Moore by deed of Claude T. Smith, dated April 15, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 621 at page 449, and by deed of Nellie M. Smith, dated April 15, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 621 at page 450. James P. Moore and Otis P. Moore conveyed their interest in the above described lot, inter alia, to Pleasant Homes, Inc., by their deed dated April 30, 1960, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 649 at page 410.
