"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina County of Greenville,

in Butler Township, on the southwestern side of Fairview Avenue, in the City of Greenville, being known and designated as lot # 20, of Block K, on plat of Fair Heights, recorded in Plat Book F at Page 257, and having according to said plat the following metes and bounds, to-wit:
