NOW KNOW ALL MEN, That I/we, the said mortgagor (a) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of three Dollars to me/us the said mortgagor (s) in hand well and druly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina County of Greenville, now within the corporate limits of the City of Greenville, on the northeast side of Low Hill Street, being known and designated as Lot Nin 6 on plat of Augusta Road Hills, made by Dalton & Neves, Engineers, December 1940; and recorded in the R.M.C. Office for Greenville County, S. G., in Plat Book L., at pages 56 and 57, and having, according to said plat and a recent survey made by R.E. Dalton, July 21, 1943, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of Low Hill Street at joint front corner of Lots Nos. 6 and 7, said pin also being 265 feet in a Southeasterly direction from the point where the Northeast side of Low Hill Street intersects with the Southeast side of Cammer Avenus, and running thence along the Northeast side of Low Hill Street, 8. 41-55 E. 60 feet to an iron pin at joint front corner of Lots Nos. 5 and 6; thence with the line of Lot No. 5; N. 48-05 E. 180 feet to an iron pin; thence with the line of Lot No. 7, 8. 41-55 W. 60 feet to an iron pin; thence with the line of Lot No. 7, 8. 48-05 W. 180 feet to an iron pin on the Northwest side of Low Hill Street, the beginning corner; being the same conveyed to me by Defense Housing Co. Inc. by its deed dated October 25, 1945 and recorded in the R.M.C. Office for Greenville County in Vol. 282, at page 101.
