NOW, KNOW ALL MEN, That the Mortgagot, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and furthersums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being in Austin Township and being known and designated as lot no, 6 on plat of property of David N. Mayfield, made by W. J. Riddle, Teb. 7, 1940, and a portion of lot on plat of survey made by E. E. Gary, Surveyer on April 18, 1947, and being more particularly described as follows:

BEGINNING at a point in the Georgia Road at corner of lot no. 5 and running thence along line of lot No. 5, S. 9-30 E. 209 feet to an iron pin, thence S 43-30 E, 81.25 feet, to IP, thence N 80-30E 148.2 feet to an iron pin, thence N-9-30W, 277.33 feet to an iron pin at corner of Georgia Road, thence S 80-30W, 104.5 feet to the beginning corner.
