organized and existing under the laws of South Carolina, a corporation hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Eleven Thousand Nine Hundred Fifty & No/100--** Dollars (\$ 11,950.00 ), with interest from date at the rate of **five and one-fourth** per centum ( **5-1/4** %) per annum until paid, said principal and interest being payable at the office of **General Mortgage Co.**

in **Greenville, South Carolina** or at such other place as the holder of the note may designate in writing, in monthly installments of **Sixty-Six and 08/100-----** Dollars (\$ **66.08** ), commencing on the first day of **November**, 19 **61**, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **October**, 19 **91**.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of **Three Dollars (\$3)** to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville** State of **South Carolina**:

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of **Greenville, County of Greenville, State of South Carolina**, being known and designated as **Lot 34, Plat of North Meadow Heights**, plat of which is recorded in the **RMC Office for Greenville County, South Carolina**, in **Plat Book W, page 183**, and having, according to said plat, the following metes and bounds, to-wit:

**BEGINNING** at an iron pin on the northwest side of **Wedgewood Drive**, joint corner **Lots 34 and 35**; and running thence along **Wedgewood Drive N. 69-00 E. 110 feet** to an iron pin; thence around the curve of the intersection of **Meadow Crest Circle** and **Wedgewood Drive**, chord of which is **N. 20-15 E. 33.1 feet** to an iron pin on **Meadow Crest Circle**; thence along **Meadow Crest Circle N. 28-30 W. 105 feet** to an iron pin, joint corner with **Lot 33**; thence **S. 61-30 W. 120 feet** to an iron pin; thence **S. 21-24 E. 112.8 feet** to an iron pin, the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
