C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Sixty-Two Hundred Fifty and No/100

DOLLARS (\$ 6250.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said-principal and interest to be repaid in monthly instalments of Seventy-Five and No/100 Dollars (\$75.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgage at any time for advances made to or for his account by the Mortgage, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hard well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted; bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece; parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

situate on the northern side of Arlington Avenue, being shown as lot # 7, Block 3, Page 77, of the City Block Book and being more fully described as follows:

BEGINNING at an iron pin on the northern side of Arlington Avenue, at corner of property formerly owned by Pope, and running thence with the line of the Pope property, N. 17 E. 150.1 feet to pin, at corner of lot conveyed to A. L. Carter by deed recorded in Book of Deeds. 192 at Page 88; thence with the line of said lot, N. 72-58 W. 60 feet to pin; thence S. 17-09 W. 1500 lfeet, more or less to pin on Arlington Avenue; thence with the northern side of Arlington Avenue, S. 72-56 E. 60 feet to the point of beginning.
