(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Twenty-two Thousand Nine Hundred and No/100ths**-----

DOLLARS (\$ 22,900.00), with interest thereon from date at the rate of **six**----- per centum per annum, said principal and interest to be repaid in monthly instalments of **One Hundred Forty-eight and No/100ths** Dollars (\$ **148.00**) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as all of Lot No. 13 and a portion of Lot No. 14 as shown on a plat prepared by Piedmont Engineering Service, dated March, 1955, entitled "Liberty Park", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book EE at page 145, and having according to said plat, when described in the aggregate, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Proffitt Circle (Drive) at the joint front corner of Lots Nos. 12 and 13, and running thence with the line of Lot No. 12 S. 6-12 E. 154.5 feet to an iron pin on the subdivision property line; thence with the subdivision property line N. 75-24 E. 203 feet to an iron pin at the rear line of Lot No. 14; thence along a new line through Lot No. 14 N. 43-26 W. 172.3 feet to an iron pin on the Southern side of Proffitt Circle (Drive) at the joint front corner of Lots Nos. 13 and 14; thence with the Southern side of Proffitt Circle (Drive) and following the curve thereof, the chord of which is S. 77-30 W., 97 feet to the point of beginning.

This is the identical property conveyed to the mortgagor herein by deed of William P. Martin and Mildred A. Martin, dated September 8, 1961, and to be recorded herewith in the R.M.C. Office for Greenville County, South Carolina.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
