TO ALL WHOM THESE PRESENTS MAY CONCERN,

(Indicates payment to Mortgagor) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S.C. (hereinafter referred to as Mortgagor) in accordance with the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100 DOLLARS (\$5,000.00), with interest thereon from date at the rate of Six (6%) per centum per annum; said principal and interest to be repaid in monthly installments of Sixty-five and No/100 Dollars (\$65.00) each on the first day of each month hereafter until the principal and interest are fully paid, such payment to be applied first to payment of interest and then to payment of principal; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sum for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns,

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Southern side of Otis Street, near the City of Greenville, being shown and designated as Lot 207 on Plat of Mill's Hill recorded in Plat Book G2, Pages 60 and 61, and having according to said Plat the following mates and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Otis Street and running thence with the line of lot 206 S. 10-12 W. 155 feet to pin; thence S. 60-43 W. 39 feet to pin in rear line of lot 209; thence with the rear line of lot 209, N. 42-30 W. 62-2 feet to pin; thence with the rear of lot 208, N. 30-13 W. 94-6 feet to pin on Otis Street; thence with the Southern side of Otis Street, N. 39-48 E. 74 feet to the point of Beginning.

Being the same premises conveyed to the Mortgagors by Charles A. and Pauline T. Moon, by Deed to be recorded here-with.

Together with all and singular the rights, members, tenements, hereditaments and appurtenances to the same, belonging or in any way incident thereto, including all fixtures, furniture, fixtures, equipment, machinery, tools, apparatus, materials, fittings, hardware, and implements, all bedding, clothing, household goods, and personal effects, and all other property whatsoever, now or hereafter belonging to the Mortgagor in respect of the same, and all rents, issues and profits therefrom.
