ALL that lot of land with the buildings and improvements thereon, situate on the Southeast side of Sutton Drive, near the City of Greenville, in Greenville County, S. C., shown as Lots 53, 54 and 55 of Block D, on plat of Mayfair Estates, made by C. C. Jones, Engineer, May 1948, recorded in the RMC Office for Greenville County, S. C. in Plat Book S, at pages 72 and 73, said lots fronting 90 feet along the Southeast side of Sutton Drive, running back to a depth of 188.6 feet on the Northeast side, to a depth of 195.4 feet on the Southwest side, and being 120 feet across the rear.
