- (1) That this mortgage shall secure the Mortgages for such further sums as may be advanced bereafter, at the option of the Mortgages, for the payment of taxes, insurance premiums, public assessments, repairs or other payment to the covenants herein. - (4) That it will pay, when due, all taxes, public assessments, and other governmental or multisipal charges, fines or other impositions against the mortgaged premises. That it will comply with all governmental and municipal laws and regulations affecting the mortgaged premises.
