WHEREAS THE Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION. GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seventy-Five Hundred and No/100-----

NOW KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Paris Mountain Township, on the southern side of Farr's Bridge Road, near the City of Greenville, being shown as lot 11 on a plat of the J. C. Hughes property made by J. C. Hill on August 3, 1959, recorded in the RMC office for Greenville County in Plat Book SS at Page 136, and described as follows:

"BEGINNING at an ion pin on the southern side of the Old Farr's Bridge Road, 123 feet east from Hughes Road, at the corner of the Hutto lot, and running thence with the line of said lot, S. 6-15 W. 275 feet, more or less, to iron pin in line of lot # 9; thence with the line of said lot, in an easterly direction 75 feet, more or less to a stake, corner of lot # 10; thence with line of said lot, N. 10-51 E. 275 feet, more or less, to iron pin on Old Farr's Bridge Road; thence with the southern side of said road, N. 80-29 W. 105 feet to the beginning corner."
