All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Western side of Jones Avenue in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 35 as shown on a plat of Crescent Ferrace, prepared by R.E. Dalton, Engineer, dated July, 1919, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book E at page 137, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Jones Avenue at the joint front corner of Lots Nos. 34 and 35, and running thence with the line of Lot No. 34 S. 89-10 W. 223.2 feet to an iron pin in the line of property now or formerly of Tindal; thence with the line of the said Tindal property S. 5-41 E. 38 feet to an iron pin; thence continuing with the line of the said Tindal property S. 84-40 W. 27.4 feet to an iron pin; thence with the rear line of Lot No. 77 S. 2-08 E. 22.9 feet to an iron pin at the joint rear corner of Lots Nos. 35 and 36; thence with the line of Lot No. 36 S. 89-10 E. 245 feet to an iron pin on the Western side of Jones Avenue; thence with the Western side of Jones Avenue; thence with the Western side of Jones Avenue N. 0-50 E. 70 feet to the point of beginning.
