"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina. County of Greenville, Greenville Township, on the North side of Marion Road (formerly Nichols Street), being known and designated as Lot No. 6 of the Subdivision known as City View Annex, as shown on Plat thereof, recorded in the R. M. C. Office for Greenville County in Plat Book G, Page 152, and Plat Book H at Pages 80 and 141, and having the following metes and bounds, to wit:
