"All that tertain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, about five miles northwest of the City of Green and one-fourth of a mile west of Milford Baptist Church, lying on the south side of the Milford Church Road, being shown on a plat of property made for the mortgagors by John A. Simmons, Surveyor, dated october 12, 1961, and having the following courses and distances, ot-wit:

BEGINNING on a nail in the center of said road (iron pin on south bank at 25.7 feet from true corner); the northeastern corner of the lot, and runs thence S. 6-33 E. 255.7 feet to an iron pin; thence S. 83-27 W. 150 feet to an iron pin; thence N. 6-33 W. 255.7 feet to a nail inthe center of said road (iron pin back on line at 25.7 feet); thence along the center of said road, N. 83-27 E. 150 feet to the beginning corner.
