NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is, hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Creenville, on the Southeastern corner of the intersection of Hiawatha Drive with Rollingbridge Drive, near the City of Greenville, shown as Lot 214 on a plat of Botany Woods, Sector V, recorded in Plat Book YY at pages 6 and 7 and according to said plat described as follows:

BEGINNING at an iron pin on the Southeastern side of Rollingbridge Drive, and running thence S. 2-06 E. 110 feet to an iron pin at the rear corner of Lot 214; thence with the line of said lot, S. 36-30 W. 190 feet to an iron pin on the Northeast side of Hiswatha Drive; thence with the Northeast side of said Drive, N. 51-15 W. 100 feet to a point; thence with the curve of the intersection of said Drive with Rollingbridge Drive, the chord of which is N. 1-0 W. 32.2 feet to aniron pin on the Southeast side of Rollingbridge Drive; thence with the curve of said Drive, the following: N. 49-08 E. 65 feet to a point, N. 34-06 E. 100 feet to a point and N. 46-45 E. 90 feet to the Regioning.
