WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and located on the

Northeastern side of Elizabeth Drive and known and designated as Lot No. 226 on a plat of the property of Robert J. Edwards, dated May, 1951, and recorded in the RMC Office for Greenville County in Plat Book EE at pages 60 and 61, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on Elizabeth Drive, joint front corner of Lots 226 and 227 and running thence N 33-30 W. 100 feet along Elizabeth Drive 100 feet to a point joint front corner of Lots Nos. 226 and 225; thence running along the line of Lots 225 and 226 N. 56-30 E. 200 feet to a point, joint rear corner of Lots 225 and 226; thence running S. 33-30 E. 100 feet to a point, joint rear corner of Lots 226 and 227; thence running S. 56-30 W. along the line of Lots 226 and 227, 200 feet to the point of beginning.
