Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

ALL that piece, parcel or lot of land situate, lying and being on Long Forest Drive, near the City of Greenville, in the County of Greenville; State of South Carolina, and known and designated as the Western 1/2 of Lot No. 39 of the Property of Nabors & Bridges, by plat recorded in the RMC Office for Greenville County, S. C., in Plat Book "O" at Page 139, and shown on a later plat as the property of Guy W. Barnett recorded in the RMC Office for Greenville County, S. C., in Plat Book "ZZ" at Page 77.
