BEGINNING at an iron pin on the western side of Brockman Avenue, at the corner of Stenhouse property, and running thence with the line of said lot, N. 60-56 W. 151 feet to iron pin; thence S. 25-05 W. 67.1 feet to iron pin at corner of property now or formerly owned by Fulmar; thence with the line of said property, S. 64-32 E. 165.8 feet to iron pin on the western side of Brockman Avenue; thence along the western side of Brockman Avenue, N. 10-08 E. 61 feet to the point of beginning.
