WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Keowee Avenue, in the City of Greenville, being shown as Lot 32 on a plat of Cherokee Park, recorded in Plat Book C at Page 96, and being more particularly described as follows:

"BEGINNING at an iron pin on the southeast side of Keowee Avenue, at the corner of lot 33, which pin is 504 feet 1 inch southwest of the intersection of said Avenue with Catechee Road, and running thence with the line of Lot 33, 8. 62-32 E. 172 feet 11 inches to iron pin on the northwestern side of a 15 foot alley; thence with the northwestern side of said alley, 8. 27-40 W. 60 feet to iron pin, rear corner of Lot 31; thence with the line of Lot 31, N. 62-32 W. 173 feet 7 inches to iron pin on the southeast side of Keowee Avenue; thence with the southeast side of said Avenue, N. 27-28 E. 20 feet to bend; thence continuing N. 28-09 E. 40 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by deed recorded in Book of Deeds 629 at Page 534, and Book of Deeds 629 at Page 525.
