All that piece, parcel or lot of land, with improvements thereon, lving and being in Bates Township, Greenville County, State of South Carolina, and having the following metes and bounds to-wit:

BEGINNING at or near curve in Road, at iron rin, common corner of Ralph E. Wells and Hudson Property, NE 26 E 200 feet, Jones line; N 58-35 E, still along said road, 200 feet to branch; thence along said branch SW 445 feet; thence N 60-10 W, 260 feet to Beginning corner, and containing three-fourths of an acre, more or less.

Above land conveyed to Julius W. Hudson by deed of Ralph E. Wells, dated September 18, 1961 and recorded in Deed Book 682, page 341, Greenville County Registry.

AND IT IS FURTHER AGREED, by and between the said parties, that the said Julius W. Hudson, his Heirs, Executors or Administrators, shall and will insure the house and buildings on said lot, and keep the same insured from loss or damage by fire, and assign the Policy of Insurance to the said Modern Homes Construction Company and in case that I or my heirs shall, at any time, neglect or fail so to do, then the said Modern Homes Construction Company may cause the same to be insured in their name, and reimburse themselves for the premium and expenses of such insurance, together with interest on the amount so paid, at the rate of Six (6%) per cent, per annum, from the date of such payment, under this Mortgage.
