Township, in the City of Green, being designated as Lot No. 15 on a plat made for Fannie M. Few by W.N.Willis in 1912, and having the following courses and distances: BEGINNING on a stake on Moore Street, corner with lot No. 16, and runs thence S. 15-58 E. 136.9 feet to a stake on alley; thence S. 76-13 W. 60 feet to a stake; thence N. 12-58 W. 135.1 feet to a stake on Moore Street; thence therewith N. 74-30 E. 60 feet to the beginning corner, and being all of that lot of land conveyed to the mortgagor by W.
