NOW KNOW ALL MEN, That I/we, the said mortgagor (s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor (s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 154 of a subdivision known as Orchard Acres, Section Two, as shown on a plat of a portion of said subdivision prepared by J. Mac Richardson, Surveyor, March, 1960, and recorded in the R.M.C. Office for Greenville County in Book QQ, at Page b, and having, according to said plat, the following meterald bounds, to-wit:

BEGINNING at an iron pin on the northern edge of Northway Drive, the joint front corner of Lots Nos. 154 and 155, and running thence along the joint line of said lots, N. 27-55 E. 160 feet to an iron pin at the joint rear corner of Lots Nos. 154 and 155; thence N. 62-05 E. 90 feet to an iron pin at the joint rear corner of Lots Nos. 153 and 154; thence along the joint line of said lots, S. 29-51 W. 160.1 feet to an iron pin on the northern edge of Northway Drive; thence along the northern edge of Northway Drive, S. 62-05 E. 95.4 feet to the beginning corner; being the same property conveyed to the mortgagor corporation by Greenville Land Co., Inc. by its deed dated November 17, 1961 to be recorded herewith.
