TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Donald E. Bolin and Ann D. Bolin, (hereinafter referred to as Mortgagor) SEND(S) GREETING.

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Nine Thousand ----- DOLLARS (\$ 9,000.00 ), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near Belvue Baptist Church, and near State Highway No. 25, containing 41.56 acres, more or less, and having the following courses and distances, to-wit:

BEGINNING at a point in the south ditch of a county road at the corner of the Lockaby property, said point being 8' north of an iron pin, and runs thence with Lockaby, S. 2-45 E. 412.5 feet to an iron pin; thence S. 14 W. 495 feet to an iron pin in ditch; thence S. 42 E. 898 feet to an iron pin at the corner of the Bishop property; thence with the Bishop line, N. 71-55 E. 434 feet to an iron pin; thence N. 87-30 E. 185 feet to an iron pin; thence N. 87-25 E. 200 feet to an iron pin; thence N. 45 E. 145 feet to an iron pin; thence N. 67-15 E. 140 feet to an iron pin; thence N. 81-15 E. 200 feet to a nail and cap in the center of county road; thence with said road, N. 38-10 W. 830 feet to a bend; thence N. 20-40 W. 248.9 feet to a nail and cap; thence leaving road, N. 46-10 W. 184.4 feet to an iron pin; thence N. 79-50 W. 242 feet to an iron pin; thence N. 11-40 E. 183 feet to an iron pin on north edge of said road; thence with the road, N. 83-15 W. 375 feet to a bend; thence S. 78-30 W. 100 feet to a bend; thence S. 59-15 W. 175.5 feet to a bend; thence S. 81-05 W. 141.9 feet to the beginning corner.
