

WHEREAS, the Mortgagor is well and truly indebted unto The Pelser-Williamston Bank

with interest thereon from date at the rate of -6

per centum per annum, to be paid: semi-annualy

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgage at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and trulp paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing Four and Twenty-one hundredths (4.21) acres more or less, situated on the Cooley Bridge Road at Wares, with the following courses and distances to-wit: with the following courses and distances to-wit:

EEGINNING at a stake on the North of siad Highway, corner of W. E. Chandler, Estate running thence N. 1h-25 E. 31.2 feet to a stake of Hra. G. W. Ware lands; thence N. 5h-05 W. 453.3 feet to a stake on Jordan lands; thence S. 28-0 W. 527.3 feet to satke on Lancaster lands; thence S. 78-35 E. 496.3 feet to a stake on Cooley Bridge Road; thence N. 39-59 E. 324.7 feet to beginning corner, according to plat of Thomas W. Welborn, August 1h, 1960.
