Lipscomb for and in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Modern Homes Construction Company according to the terms of the said note and also in consideration of the further sum of THREE DOLLARS to me tox the said Richard B. All that certain riece, rarcel or lot of land, with improvements thereon, situate, lying and being in Greenville County, State of South Carolina, and more particularly described as follows:

BEDIAMING at a nail car in the center of the McElhaney Road, said nail car being at the intersection of a private road and McPhaney Road, and runs thence N-25-30 W, 101.6 feet to an iron rin in aforesaid private road which has an offset of 8 feet; runs thance N 51 %, 74.4 feet to an iron rin; runs thence S f2-15 %, 12^{4} feet to an iron nin; wuns thence S 51 E, 74.4 feet to an iron pin; runs thence S 25-30 E, an indiring nums intence 5 hi E, 74.4 feet to an iron pin; runs thence 5 25-30 E, 101.6 feet to an iron pin in the center of McElhaney Road; runs thence along McElhaney Road N 62-15.E, 125 feet to the point and place of heginning, containing ne-half (1) acre, more or less of that certain 3.94 acres, of the Roach procerty, conveyed to Richard P. AND it is agreed by and between the said parties that in case of default in any of the payments of interest or principal as herein provided for, the whole amount of the debt secured by this mortgage shall become due and payable at once.

AND IT IS FURTHER AGREED, by and between the said parties, that the said Richard B. (J.) Lipscomb, his Heirs, Executors or Administrators, shall and will insure the house and buildings on said lot, and keep the same insured from loss or damage by fire, and assign the Policy of Insurance to the said Modern Homes Construction Com-

pany, and in case that I or my heirs shall, at any time, neglect or fail so to do, then the said Modern Homes Construction Company may cause the same to be insured in their name, and reimburse themselves for the premium and expense of such insurance, together with interest on the amount so paid, at the rate of Six (6%) per cent, per annum, from the date of such payment, under this Mortgage.

And it is Further Agreed and Covenanted, by and between the said parties, that until the debt hereby secured be paid, the said Mortgagor his Heirs Executors, Administrators or Assigns, shall and will pay all taxes on the property hereby mortgaged, when due and payable, and in case said mortgagor (s) shall fail to do so, the said Mortgagee, its Executors, Administrators or Assigns, may pay said taxes, together with any costs or penalties incurred thereon, or any part there of, and reimberse itself for the same, together with interest on the amount so paid, at the rate of Six (6%) per cent, per annum, from the date of such payment, under this Mortgage.
