The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt_and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being the greater portion of Lot No. 20 and small portions of Lots Nos. 19 and 21 of a subdivision known as Dogwood Terrace as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book UU, at Page 5, and being also known and designated as Lot No. 20 as shown on plat entitled "Revision of Lots Nos. 19, 20 and 31, Dogwood Terrace, Property of Mauldin Construction Co." prepared by C. C. Jones, C. E., August 11, 1961 and having, according to the last-mentioned plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern edge of Alpine Drive, the joint front corner of Lots Nos. 19 and 20 as shown on the Jones plat above-mentioned and running thence along the joint line of said lots, S. 82-38 E. 100 feet to an iron pin; thence continuing along joint line of said lots, S. 47-16 E. 96 feet to an iron pin; thence S. 53-42 W. 151 feet to an iron pin, the joint rear corner of Lots Nos. 20 and 21; thence along the joint line of said lots (as shown on the Jones plat abovementioned), N. 43-07 W. 158.7 feet to an iron pin on the southeastern edge of Alpine Drive; thence along the southeastern edge of Alpine Drive, N. 68-26 E, 18 feet to an ipon pin; thence along the southeastern edge of Alpine Drive, following the curvature thereof, the chord of which is N. 44-19 E. 62.3 feet to the beginning corner, being the same property conveyed to me by Mauldin Construction Co. by its deed of even date to be recorded herewith.
