WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith; the terms of which are incorporated herein by reference, in the sum of Two Thousand One Hundred and No/100

DOLLARS (\$ 2,100.00), with interest thereon from date at the rate of Six and One-half per centum per annum, said principal and interest to be paid as therein stated, and (6 1/2%)

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown and designated as Lot 18 Cedar Falls Road on a plat entitled "Subdivision of the Residential properties of Fork Shoals, South Carolina of Riegel Textile Corporation, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book "BB" at Page 156 and Page 157, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the northeastern side of Cedar Falls Road at the joint front corner of Lots 17 and 18 and running thence with the joint lines of said lots N. 71-20 E. 160.3 feet to an iron pin; thence N. 22-05 W. 106 feet to an iron pin; thence S. 67-55 W. along the joint lines of Lots 18 and 19 160' to an iron pin on the northeastern side of Cedar Falls Road at the joint front corner of Lots 18 and 19; thence with the said eastern side of Cedar Falls Road S. 22-05 E. 96 feet to the point of beginning.
