(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

-----Seventy-Five Thousand and No/100-----
DOLLARS (\$ 75,000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid in monthly instalments of Seven Hundred Fifty and No/100 Dollars (\$750.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the eastern side of U. S. Highway # 25, in Bates Township, containing 10 acres, more or less, shown on plat entitled "Property of Northside Greenhouses, Inc." prepared by J. C. Hill on June 5, 1961, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern edge of said highway, at the joint front corner of the Glenn Property, and running thence along the line of the Glenn property, N. 88-55 E. 1157.7 feet to an iron pin; thence S. 5-07 E. 464 feet to an iron pin at the corner of the remaining property of grantor; thence along the line of the property of Waymon Chastain, N. 82-40 W. 1167.4 feet to an iron pin on the eastern side of said highway; thence with the eastern edge of said highway the following courses and distances: N. 1-40 W. 100 feet to an iron pin; thence N. 7-45 W. 100 feet to an iron pin; N. 12-30 W. 100 feet to the point of beginning.

Being the same premises conveyed to the mortgagor by deed to be recorded.
