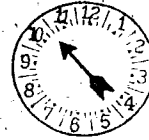

WHEREAS, the Mortgagor is well and truly indebted unto Institute For Essential Housing, Inc., a corporation organized and existing under the laws of New Jersey, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Nine thousand two hundred thirty-six and 16/100

NOW; KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors

and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

From an iron stake at the junction of Pinefield Drive and Plainfield S 5-01 E 147 feet to a stake; S 5-01 E for 110 feet, S 84-59 W for 135 feet, N 1-25 E for 110 feet thence S 88-34 E for 135 feet back to the point of beginning, containing one quarter of an acre more or less and being a part of tract #4 from property of Edward and Martha Rosamond Estate surveyed by C. O. Riddle, September 1959.
