NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, near the town of Piedmont and on the East side of the C. & G. Railroad, in said county and State, being Lot No. 2 of the W. P. Besbitt "Oil Mill" tract or subdivision, which subdivision was made by W. P. Lee January 1924. Said lots fronts the South side of a twenty foot street or road 90 feet and runs back in parallel line 117 feet. See plat recorded in Plat Book I, page 55, to which references is here made as a part of this description. Said lot contains Three-fourths of an acre, more or less, and being the same lot conveyed to the Grantor above named by J. P. Chappell by his deed dated February 23, 1950, and recorded in the R. M. C. office of Greenville County in Book 403, page 255.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
