All that certain place, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

All those places, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lots Nos. 16, 18, 19, 20, 24, 26 and 27 of Blarndale Manor as shown on plat thereof recorded in the R.
