"ALL that dertain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying end being in the State of South Carolina, County of Greenville, and in Gantt Township, near Cantt Station, being shown as Tract No. 3 on plat of property entitled Property Plat of W. F. LaBoone Estate recorded in the R. M. C. Office for Greenville County in Plat Book 88, at page 97, and having the following metes and bounds according to said plat:

BEGINNING at a point in the center of Murrell Drive joint front corner of Tracts Nos. 2 and 3, ( iron pin being located on joint line of Tracts Nos. 2 and 3 at distance of 27 feet from the beginning point); and running thence along the center of Murrell Drive; N. 67-18 E. 258.7 feet to a point in the center of Murrell Drive; thence continuing along the center of Murrell Drive, N. 14-12 E. 85 feet to point on line of Poplar Valley Property (iron pin being located on line in easterly direction 12 feet from said point); thence S. 32-35 E. 99.7 feet to an iron pin; thence along the line of Earle property, S. 32-35 W. 296.5 feet to an iron pin; thence N. 58-58 W. 219.5 feet to the beginning corner.
