"BEGINNING at an iron pin on the northern side of Chantilly Drive, at the joint front corner of Lots 164 and 165, and running thence along the line of Lot 165, N. 29-55 B. 118 feet to iron pin at the corner of Lot 163; thence along the line of Lot 163, S. 84-16 E. 136.4 feet to iron pin on the western side of Wilmington Road; thence along the western side of Wilmington Road; thence along the curve of the intersection of Wilmington Road and Chantilly Drive (the chord of which is S. 48-34 W. 30.9 feet) to an iron pin on the northern side of Chantilly Drive; thence along Chantilly Drive, N. 79-30 W. 104 feet to iron pin; thence continuing along Chantilly Drive, N. 67-58 W. 80 feet to the beginning corner; being the same conveyed to the mortgagor corporation by Botany Woods, Inc. by deed dated January 17; 1962, to be recorded herewith."
