That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant; bargain, sell and release unto the Mortgagoe, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Smythe Street, near the City of Greenville, being shown as Lot 113, on a plat of Section 4 of Dunean Mills recorded in Plat Book S at Page 173, and described as follows:

BEGINNING at an iron pin on the western side of Smythe Street at the corner of Lot 114 and running thence with western side of street, N. 11-34 E. 79 feet to an iron pin at the corner of Lot 112; thence with line of said lot N. 78-44 W. 132.6 feet to an iron pin on an alley; thence with eastern side of said alley S. 2-33 W. 54 feet and S. 11-48 W. 16.5 feet to an iron pin at the corner of Lot 114; thence with line of said lot S. 74-40 E. 124.4 feet to the beginning corner.
