(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

**Fourteen Thousand and No/100** DOLLARS (\$ **14,000.00** ), with interest thereon from date at the rate of **Six (6%)** per centum per annum, said principal and interest to be repaid in monthly instalments of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the Northwestern corner of the intersection of Markley Street and Rhett Street in the City of Greenville being the same property conveyed to the Mortgagor by deed recorded in Deed Book 546 at Page 326 and having according to a survey and plat made by C. O. Riddle, dated January 8, 1962, with the following metes and bounds, to-wit:**

**BEGINNING at an iron pin on the Northwestern corner of the intersection of Markley Street and Rhett Street and running thence along the Northern side of Rhett Street, N. 70-30 E. 95.95 feet to pin at the corner of property owned by Textile Warehouse, Inc.; thence with the line of said property N. 18-36 W. 65.05 feet to an iron pin; thence continuing with the line of property of Textile Warehouse, Inc., S. 71-16 W. 96 feet to an iron pin on the Eastern side of Markley Street; thence with the Eastern Side of Markley Street S. 18-41 E. 66.3 feet to point of beginning.**

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
