"BEGINNING at an iron pin on the Northeast side of Windfield Road at joint front corner of Lots 17 and 18, and running thance with the line of Lot 17, N. 55-49 E. 163.1 feet to an iron pin in the center of branch; thence along the center of branch (the traverse line being N. 16-51 W. 109.6 feet) to a point in the center of branch; thence along the line of Lot 20, N. 74-30 W. 71.5 feet to an iron pin; thence along the line of Lot 19, S. 31-42 W. 190 feet to an iron pin on the Northeast side of Windfield Road; thence with the curve of Windfield Road (the chord being S. 50-36 E. 84.3 feet) to the beginning corner; being the same property conveyed to the mortgagor corporation by William L. Costner by his deed of even date to be recorded herewith."
