TO ALL WHOM THESE PRESENTS MAY CONCERN:

J. A. PATTON

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Twelve Thousand and No/100** -----

DOLLARS (\$ **12,000.00**), with interest thereon from date at the rate of **Six (6%)** per centum per annum, said principal and interest to be repaid in monthly instalments of **One Hundred and No/100** ----- Dollars (\$ **100.00**) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Fairview Township, containing **80 acres, more or less, lying on the Western side of Neely Ferry Road, being shown on a Plat entitled property of J. A. Patton, prepared by W. J. Riddle, R. L. S., dated October 15, 1954, and having, according to said Plat, the following metes and bounds, to-wit:**

BEGINNING at an iron pipe in the center of the Neely Ferry Road, and running thence along said Road, N. 9-58 W. 252.1 feet to an iron pipe at the Intersection of the Georgia Road; thence still with the Neely Ferry Road, as follows: N. 15-28 W. 717.8 feet to a bend; thence N. 8-24 W. 567.4 feet to a bend; thence N. 00-58 W. 807.5 feet to a bend; thence N. 6-13 E. 270 feet to an iron pipe on the Western side of Neely Ferry Road; thence along the line of Thompson property, N. 65-44 W. 970 feet to an iron pipe; thence with the Garrett property, S. 6-00 W. 1746 feet to an iron pipe in a ditch; thence S. 78-15 W. 546 feet to an iron pin; thence with the line of Alverson Estate property, S. 3-45 E. 710 feet to an iron pin; thence with the line of Jane Locke Estate property, S. 64-30 E. 1450 feet to an iron pin in the Georgia Road; thence along the Georgia Road, N. 46-00 E. 140 feet to an iron pin; thence N. 76-30 E. 444.4 feet to the point of BEGINNING in the Neely Ferry Road.

Being the same premises conveyed to the Mortgagor by Deed recorded in Deed Book 368, Page 488.

Together with all and singular the rights, members, hereditaments and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
