All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Saluda Township, on the western side of Buncombe Road, known as the U. S. Hwy. No. 25, containing 0.63 acre, more or less, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of U. S. Hwy. 25 at the corner of property now or formerly of Louie Burdine, running thence S 67 W, 185 feet to an iron pin; thence S 13 E, 145 feet to an iron pin; thence N 71-30 E, 180 feet to an iron pin on the western side of said highway; thence with the Highway, N 13-20 W, 153 feet to the point of beginning and being the same conveyed to the trustees of the Church of God of Slater, S.
