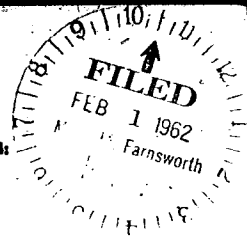

MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:



WHEREAS, We, John T. & Fannie C. Bryant

(hereinafter referred to as Mortgagor) is well and truly indebted unto DELTA CONSTRUCTION COMPANY, INCORPORATED

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of TWO THOUSAND ONE HUNDRED NINETY THREE and 60/100 Dollars (\$ 2,193.60) due and payable at the rate of \$36.56 per month for 60 consecutive months, commencing on the 12 th day of March, 1962 and the 12 th. day of each month thereafter until the entire balance is paid in full
