

AGREEMENT FOR PAYMENT FOR RESIDENTIAL ELECTRIC WIRING

This Agreement made this 6th day of Apr. 1960 between Duke Power Company (hereinafter called Utility) and Blanche P. Vega (owner), whose address is 106 Ebaugh Greenville South Carolina, hereinafter called Owner) and Bradley Electric Greenville South Carolina, hereinafter called Contractor) whose address is 408 Overbrook Road, Greenville, South Carolina (hereinafter called Contractor).

WITNESSETH: Owner certifies that he is the owner of the residence located at 106 Ebaugh Greenville South Carolina, and that he has entered into a contract with said Contractor to increase the number of electrical outlets, enlarge and/or extend the conductors and otherwise modernize and render more adequate the electrical wiring on such premises at a price and upon the terms set forth below:

*To be made directly to Contractor. Owner shall pay installments due hereunder at the office of the Duke Power Company. Owner shall pay the aforesaid time balance in consecutive equal monthly installments of the number and amount as above set forth, the first of which shall be due and payable at the same time as the next succeeding Utility service bill is payable in respect to said premises and each subsequent installment shall be due and payable each month thereafter. In all events, the first installment shall be due not later than sixty days from the date hereof and subsequent installments shall be due monthly thereafter. Owner's failure to receive notice of the maturity of any installments shall not relieve Owner of any of his obligations hereunder. It is mutually understood and agreed that the Owner hereby releases and discharges the Utility from any liability for damages suffered by reason of the installation, maintenance and/or removal of any wiring now on Owner's premises or hereafter installed thereon. Contractor hereby assigns said agreement to the Utility and Owner does hereby agree to said assignment and agrees to pay said installments to the Utility or its assignee in accordance with the terms of said agreement. If any installment of this agreement shall not be paid promptly, the entire unpaid amount shall forthwith become due and payable.
